Pour Hull & Bottom into a bucket and apply to surface that needs to be cleaned with a brush or apply directly to surface with a chemical resistant sprayer or pump sprayer. Let product soak/dwell for 30 seconds to 5 minutes, depending on degree of dirt, and a company of the surface as needed. Rinse thoroughly with fresh water. Repeat application steps as necessary. If used around metal or delicate surfaces, thoroughly clean the affected area with **Ditec Boat Soap** or **Degreaser**.
